- 5. Chair's Report

- 7. Forestry Conclave Appeal ACTION

Forestry Conclave is requesting to use their current year IRA allocation for additional club activities. Because these activities were not included in the approved IRA application, the committee must approve these changes. Specific requests: (1) reimburse Logging Sports Club \$900 to pay for team registration fees to participate in a home event; (2) reimburse Logging Sports Club \$480 to pay for team registration for event at UC Berkeley; (3) they are requesting an exception to the fuel reimbursement rate for instructor to tow the club's equipment trailer ( $\$.14 \rightarrow \$.58$ ).

Clarification: Forestry Conclave is the name for the group of class competitors; Logging Sports Club is the name of the club.

- (1) Gonzalez moved to reimburse Logging Sports Club \$900 to pay for team registration fees to participate in a home event; no second; motion died.
- (2) Woods moved to reimburse Logging Sports Club \$480 to pay for team registration for event at UC Berkeley; seconded by Gonzalez; votes: 2 yes, 1 no, 2 absentions; motion failed.
- (3) Hayes moved to pay faculty state government rate for fuel reimbursement for the truck that is towing a trailer with the Conclave's equipment; seconded by Woods; unanimously passed.
