  - A. Review and Approval of the 2010-2011 Associated Students Budget – Action Item

The Board of Finance forwarded the recommended budgets for A.S. Programs to Council on March 8<sup>th</sup>, 2010. Council is scheduled to act at this meeting on the 2010-2011 Associated Students recommended budget. If A.S. Program Directors wished to appeal the

Board of Finance's recommendation to Council, they were to deliver 20 copies of their appeal narrative and justification to the Associated Students Business Office no later than 5:00 p.m. on March 30<sup>th</sup>, 2010. Each program that appeals will be given five minutes to make their presentation to Council and Council will be given five minutes to ask questions. No adjustments will be made until all of the programs requesting appeals have been heard.

It is also possible that Council may decide to call in programs for which they have questions. If that happens, programs selected will be asked to appear at the following A.S. Council meeting, scheduled for Monday, April 12<sup>th</sup>, 2010 at 2:00 p.m. If a program is not called in by Council, and the program does not appeal, the program will not have their recommended budgets altered. (Please note: for a program to be called in by Council, at least a majority of the members must vote to do so.)

Following hearing appeals, Council will make a motion to approve, proceed through budget language and each A.S. Program providing an opportunity for discussion, questions, comments, and/or amendments followed by a vote.

Proposed changes to the Administrative Code would delete the Student Interrelations Committee for Quality Academics.

Chapin explained that the Student Interrelations Committee for Quality Academics would be deleted from the code if this resolution were to be passed. Chapin further explained that the committee's mission is very vague and that no student had ever been appointed to the committee. Rodriguez asked if the committee could be restructured to be more useful. Chapin responded that could be done, however the Cabinet for Institutional Change has recommended that many campus committees be suspended or deleted to allow for better governance on campus.

Wilyer thanked McWatters for driving the van for the event. Wilyer stated that the rally was successful and that 20,000 students were in attendance. CSSA had a meeting at CSU Dominguez Hills from March 12<sup>th</sup> – 14<sup>th</sup>. Wilyer also announced that the California Higher Education Student Summit will be April 23<sup>rd</sup> – April 26<sup>th</sup> and encouraged Council members who may be interested in attending to contact him.

The SLAM Festival is requesting access to \$668.44 for additional expenses not requested in the SLAM Festival Budget.

Gradine reported that the Board approved the request from the SLAM Festival from their trust account.

### **President (Brandon Chapin)**

Chapin reported that Eden was appointed to the Cabinet for Institutional Change Implementation Steering Committee and that Wilyer was appointed to the Affordable Classroom Technology Steering Committee. Chapin encouraged the Council to browse the Affordable Technology Website. Chapin also reported that he met with President Richmond regarding the names of the buildings in the new College Creek housing complex and informed the President that names that were nominated by RHA were not considered. Chapin noted that President Richmond stated that he would look into the matter. The Student Fee Advisory Committee will be meeting on Friday to discuss the Materials, Facilities and Services Fee proposal. The fee would be \$72.00 a semester for students with 5.9 or less units and \$144.00 a semester for students with over 6 units. Chapin is working on a resolution to place the fee as a referendum on the ballot in April and will continue to inform the Council about the fee. Tyson and Chapin presented information about the Associated Students to the University Budget Committee last Friday. Over Spring Break Chapin attended the CSSA meeting at CSU Dominguez Hills, the Board of Trustees meeting at the Chancellor's Office and the rally in Sacramento. Chapin also reported that Associated Students organizations in the CSU will no longer be collecting revenue from the summer semester because the sessions have been moved to Extended Education programs. Chapin also noted that the Board of Trustees is discussing an early start program for incoming students to fulfill remedial courses before entering their freshman year.

### **General Council Discussion**

Gradine reported that a binder is available in the AS Office with the budget requests from each of the AS Programs. Rodriguez asked Chapin if the costs associated with the *Coral Sea* will be included in the proposed fee. Chapin stated that it would be included. Wilyer asked for clarification on the referendums going on the Associated Students' ballot. Chapin replied that the Counseling Fee, IRA Fee, Materials, Facilities and Services Fee and the Smoking Policy would be included on the ballot. Wilyer also reported that he will be meeting with staff from Wes Chesbro's office and is looking for additional Council members to go with him. Brownell asked if the costs to attend summer school would be lower since it would be offered through Extended Education. Chapin stated that summer session would not include any subsidy from the state, so students would be paying the full cost of the courses they are taking.



## General Council Work Session

- A. College Mixers – Discussion Item  
Council members will discuss plans for their Spring 2010 College Mixers.

Rodriguez reported that Romero did an excellent job advertising for the COPS mixer and getting the word out about the event. Romero noted that Fridays are a difficult day for the event because the campus is relatively quiet. Parra reported that they are waiting for a reply from Arcata Scoop to provide Ice Cream for the CNRS mixer. Armstrong noted that the CAHSS mixer will be next week and will include pizza from Live from New York, Big Pete's and Smugs. The CAHSS mixer will also have a live string quartet.

## Announcements

Chapin announced that the search for a new Dean for the College of Arts, Humanities and Social Sciences was unsuccessful and that a new search will be done. The College of Professional Studies will have a new Dean that will begin on July 1<sup>st</sup>. Parra announced that the LEAP program's Chocolate Iron Chef contest will be on April 1<sup>st</sup> from 11:00 a.m. – 2:00 p.m.

Dear Members of the Board of Finance:

First of all, I would like to thank Associated Students for your continued support of the MultiCultural Center (MCC). We have established a positive partnership between AS and the MCC, and together we can continue to offer our students social justice programs, cultural celebrations, leadership development, and creative problem solving.

In response to the AS 2010 – 2011 Fiscal Year Recommended Budget, I would like to address two items that are in the MultiCultural Center's budget. The first item is number 2 in the budget language, which reads:

**2. MCC COORDINATORS SHALL MEET WITH THE BOARD OF FINANCE EARLY IN THE FALL SEMESTER TO DISCUSS THE FUTURE POTENTIAL OF TRANSITIONING THE Q-FEST COORDINATOR FROM THE MCC TO THE ERIC ROFES QUEER RESOURCE CENTER.**

The annual Cross Cultural Queer Film Festival (Q-Fest) is a program that was created and developed by student staff in the MCC about seven years ago. I do not understand why this important cross-cultural MCC program should go to the ERC. Is it because the program is "queer" and therefore should be in the "queer" program? When planning the Q-Fest, the Coordinator(s) collaborate with the ERC, QSU, Multicultural Queer Studies, and others who are interested but not in a club or program. The history of the Q-Fest is rooted in community cross cultural collaboration. I would really like to keep the Q-Fest as a program of the MCC. I do not agree with your recommendation to move the Q-Fest program to the ERC.

The second item is number 3 in the budget language, which reads:

**3. HOURLY AND WORKSTUDY WAGES ARE CALCULATED AT AN AVERAGE OF \$8.00 PER HOUR.**

An **average of \$8.00 per hour** implies that there are wages higher and lower than \$8.00. Because we do not pay anyone below the minimum wage of \$8.00, the use of the term "average" is incorrect. When determining the hourly wage for MCC employees, we have always used the "Associated Students Hourly Wage Scale" located as Example 10 in the Policies and Procedures section of the AS Budget book. All MCC employees are hired at minimum wage. If they return to work at the MCC the following year and if they have proven to be reliable, dependable and competent, then a \$.25 raise is given because it is well-deserved. Item #3 should either be removed or should read: HOURLY AND WORKSTUDY WAGES ARE CALCULATED ACCORDING TO THE ASSOCIATED STUDENTS HOURLY WAGE SCALE.

I will be happy to discuss these recommendations/concerns with you. Thank you.

**SUBJECT: Resolution In Support of Affordable Textbooks and Affordable Alternatives**

- 1.) **WHEREAS**, The Associated Students of Humboldt State University have been entrusted to voice the interests, concerns, and opinions of the students to the faculty, administration, and local community; and
- 2.) **WHEREAS**, The Associated Students of Humboldt State University have witnessed a rapid increase in the cost of education. The combined cost of textbooks, tuition, student fees, and living expenses have forced many students to take out excessive loans; and
- 3.) **WHEREAS**, It is prerogative of professors at Humboldt State University to select which textbooks will be used for their classes; therefore, be it
- 4.) **RESOLVED**, The Associated Students of Humboldt State University encourage professors to provide students with access to more affordable textbooks. Professors should be encouraged to notify students in advance of the books that will be required for the course. This will give students an opportunity to find low priced textbooks; and be it further
- 5.) **RESOLVED**, The Associated Students of Humboldt State University support efforts made by professors to provide students with access to more affordable textbooks. Professor should be encouraged to research the textbook that they plan to use for their class. E-books provide students with online and downloadable versions of textbooks for a fraction of the cost of traditional paper textbooks; and be it further
- 6.) **RESOLVED**, The Associated Students of Humboldt State University also support professors who prepare their own instructional materials that are used in place of purchased text, by this formal petition to the President and Chancellor to allow course material fees to be charged and paid to professors who replace expensive texts with their own materials; and be it further
- 7.) **RESOLVED**, The Associated Students of Humboldt State University require that the resolution be sent to the following: CSU Chancellor, Charles B.
