Avitia reported she will be meeting with Oh Snap! Avitia would like to create a new sustainability representative position on the AS Council. Avitia summarized that at the prior University Senate meeting members discussed a resolution changing Constitutional by-laws and that the California Faculty Association will hold a bargaining meeting. Blake announced HSU enrollment rates are low and the resident capacity is at 99%. Alex Enyedi, Provost and Vice President of Academic Affairs, updated the Senate on WASC and the HSU's strategic plan. A resolution on intellectual rights was proposed, deliberated and passed two resolutions: Resolution Demanding President Rossbacher Approve the University Senate Recommended Intellectual Property Policy and Resolution to Amend the Bylaws of the University Senate to Clarify Quorum Requirements for Standing and Ad Hoc Committees.

Morgan reported she met with Arcata City Council members regarding outreach and building relationships. Morgan would like to have a world café with the Arcata City Council. Morgan also suggested having an AS Council member attend the Arcata City Council meeting. Morgan asked the Council who could attend the city council meetings. No one has been identified to date.

Zivolich reported she would like to work on HSU divestment. Zivolich will attending a meeting with Mira Friedman, Health Educator, and would like to work on student tenant rights with Cota and Delcastillo.

### General Council Discussion

Cota asked Zivolich the meeting time for the Food and Housing Alliance which will be Tuesday, September 20 from 5:30 to 6:30 p.m. in the Recreation and Wellness Center, Room 124.

Blake noted the AS Council is working on projects that other campus working groups are already addressing. Blake told Zivolich to talk to Craig Wruck, Vice President of Advancement, about HSU divestments. Blake said the Strategic Edge was disappointed by the lack of attendance by students and the AS Council. Blake announced HSU representatives will be talking to housing management companies in the local area and AS Council members can attend.

Cota asked Blake about the Strategic Edge and what sports are represented in that. Blake said Division II sports are represented.

# **General Council Work Session**

A. AS Working Groups – Discussion Item (Jonah Platt)
Platt will facilitate a discussion on each working groups goals, updates, and how the Council can support the groups.

Jonah asked each group to state their goals and update the Council on their progress.

Outreach Group – Lance reported for the group and stated the group has been working on short and long term goals. The task for the week is to create posters with the each of the representative's picture, biography, and contact information to be distributed across the campus. The group is also developing themed AS Council "meet and greet" events.

The group has been discussing providing incentives for committee members and would like the Council to attend the "Forever Humboldt Presents HSU Downtown DJ Night" at the Arcata Theater Lounge September 29, at 9 p.m.

Community Empowerment Group – Morgan said the group has been meeting to align personal goals with group goals. McGuigan reported he wanted to work on structural change within AS and HSU. Young would like to work on student mental health issues on campus.

Housing – Cota talked about wanting to destignatize homelessness and is developing a pamphlet on tenant rights for students. The group would like to work with Betty Chinn, a Eureka community member. Delcastillo is interested in the legal resource center on campus.

Platt noted Rodriguez was interested in having a legal resource center. Platt would also like to have more speakers focusing on legal rights of students. Platt is working with faculty members on creating a legal rights class and workshop.

Cota announced the "Campus Dialogue on Race" is a good event for students to attend and present.

B. AS Welcome Back BBQ and Open House – Discussion Item (Candace Young)
Young will provide an update on the A.S. Welcome Back BBQ, discuss having an AS Open
House, and will let Council know what assistance is needed.

Young will be developing an "AS Open House" event. The purpose of the event is to inform students what AS does. Young will be contacting AS Council members regarding their availability for the event.

C. Building Group Organization – Information Item (Jonah Platt)
Platt will provide information on building an effective group and include online group organizational websites such as Trello and Groupme.

Platt showed a video of Trello, an online group organizational tool, to the Council and explained the importance of group communication.

Blake left the meeting at 4:41 p.m.

There was discussion of the pro's and con's of Trello, Google documents and other tools.

Cota left the meeting at 4:51 p.m.

Navarro suggested asking each group to choose what group organization tool they want to use. Platt stressed that he wanted each group to be in communication with him.

Platt will be working with the AS staff to create Trello groups.
